





# WARRIOR WELLBEING ARTICLE

### **Too Strong and Too Silent**

It is common for us to be called to help men in the country with what is a seemingly without notice separation that leaves a dumbfounded male struggling to make sense of what just happened. Today women are more likely to be career-oriented, more independent financially, more educated and empowered. Divorce no longer carries the stigma it once did and rightfully women no longer are as accepting of abuse or not having their needs met.

Given this societal change there is an even greater need now for effective communication in relationships. Getting men to talk more is slowly changing, however, too often men tend to be stoic and un-communicative about how their relationship is going: *Too Strong and Too Silent*.

Relationships breakdown for many reasons. For example, emotional disconnection, differing views on finances, too much work, not enough time with the family, stonewalling, lack of respect, or not being appreciated to name just a few.

If we don't communicate what is going on within us, we are not resolving our issues and setting up our relationships to fail. A common quote is 'I tried but he just never listens', or 'I work hard every day, dawn to dusk to provide, I thought I was doing the right thing'.



If we talk about things as they arise, resolution is more likely. Men tend to be too silent but again women can be bad at communicating as well. I often hear comments like 'if only she had said something', or 'I didn't know'. Chances are maybe we were told or didn't want to deal with it or simply didn't listen. We need to learn to communicate more and listening to our spouse is paramount.

Here are 4 tips to improve listening skills:

- 1. Body language: we may say we're listening to our spouse, but the body language says otherwise. Body language accounts for 93% of communication. Face each other, look into our spouse's eyes. Be cautious about our pose, things like being fidgety or folding your arms, tends to give a message of disinterest.
- 2. Ask questions: asking questions shows that we are interested and heard what was said i.e. 'so, then what happened?' or paraphrase 'so what you're saying is...'
- 3. Avoid one-upmanship: listen to the bad day story without jumping in with your worse bad day. Instead ask questions, listen, and show interest, otherwise the message our spouse gets is we don't really care.
- 4. Don't try and fix it: this is a vital thing to remember for blokes. Men will often offer a solution to the problem and try to fix it. We just need to listen and be engaged. Women prefer that blokes don't jump in with their best solution unless asked. Good effective communication is essential for a healthy relationship, don't be too strong and too silent.

I can no longer be silent about the way in which the frail aged in our community are being treated by our own World Class Health Department. I believe we have a World class health system which is by far, second to none in this world. We have excellent, well trained, passionate, dedicated people who go to enormous lengths to do the best they can when it comes to looking after us and our loved ones. And we can all know this by our own, very, very well equipped local hospital in our Boddington, with just as well equipped, staff. But seriously people, we are missing the mark when it comes to the care of our most vulnerable, frail, elderly, somewhat silent residents. I say silent because even though they can still obviously speak, accessing and navigating the internet and even mobile phones can be very problematic for them. They are no longer being heard as they don't speak this language. They are for the most part the forgotten.

Why is it that over the years we have cared for our elderly, here in Boddington, in our own hospital, when they were not able to look after themselves any more, and done it very well. Now we send them away as if they are a problem to us, a risk that cannot be managed at local level.

They certainly weren't a problem when they were able bodied, taught our children, nursed in our hospital, built our town and passed down their knowledge to us.

Please let us not forget the Golden Rule...'So whatever you wish that others would do to you, do also to them....'.

How would you personally like to be sent away from the community where you were born and raised , lived , brought children into the world, grew, loved, worked and payed taxes, to be sent away at the frailest time in your life to a place where you are no longer known. You are now a stranger. And you are old and don't speak the language any more. Nothing makes sense to you.

Are our elderly such a problem to us that we have to move them along so that others can take care of them? Don't you think we should be taking care of our own? Here. Now.?

Whether we like it or not, one day we will be judged on how we treat each other. And how we live our lives will be reflected in our generations to come. What are we teaching our younger generation that will one day be caring for us? You will need to get out of town, you are now a problem for us, too big for us to manage.? Move out. Who will visit you when you are out of sight and too far for your friends and loved ones drive? (don't forget they get old as well?).

This nightmare has very sadly become reality for our frail aged in our own community, and I consider this a privilege to speak on their behalf, an honour.

What is the issue? And what has been the issue of not being able to now look after elderly in our own hospital.? (it's OUR hospital!!) Do you know that some of the people that once cared for you we can no longer care for here?

If lack of suitable staff is the issue,,, Let's buy some!!!!

We live on a GOLD mine!!!! Our country is RICH!!!! Our health department is WORLD CLASS!!

So I sincerely would ask what is our problem.?

For a long time groups of dedicated, concerned, locals have done a lot of work on trying to establish an Aged Care Facility in Boddington. This news is not new, most of you are aware.

I pray that this becomes a reality as we desperately, desperately need it. But in the interim, and in the years to come whilst we wait for bureaucrats to make up their minds up about our futures...

Where will our precious elderly go? When our indigenous elders have to leave home (here) to live in someone else's town (there). Isn't that disgraceful?

When someone tells you that they would rather die than leave their home town, to go to have strangers care for them because they can't stay here, people we seriously need to sit up and ask the question, Why and how have we allowed this to happen?

WE have a voice. Let's use it people.

Please consider signing petitions that will be around your town soon.

I am not going to be silent any more.

#### Living by the law: what you need to know before share housing

Splitting a rental with mates or even people you find through an advert can be a smart way to tackle soaring rent prices and low vacancy rates. But before you start dividing up chores and discussing furniture options, it's important to understand your legal rights and responsibilities when it comes to share house arrangements.

In co-tenancies, there is a shared tenancy agreement, but all tenants are jointly responsible for the full rent amount, bond and condition of the entire property. This means if your house mate misses a rent payment, for example, the whole household could be at risk of breaching the tenancy agreement unless they can cover the outstanding amount.

When it comes to paying the bond, each contributor must be listed against the bond as a tenant. The private landlord or agent then has 14 days to lodge the bond with the Bond Administrator.

Consumer Protection has recently had two real estate agencies and directors fined and reprimanded for failing to lodge tenancy bonds within the required timeframe. Renters deserve peace of mind knowing their bonds are being handle by landlords and agents in accordance with the law.

It is important tenants receive an immediate receipt of their payment. The Bond Administrator will also send the tenants and the private landlord/agent a record of the payment directly from the department. This also ensures each tenant is returned their correct share of the bond when the tenancy ends.

If you move out of a share house, negotiate to have your name removed from the tenancy agreement. If you fail to do this, you can still be held responsible for the rent and other obligations. Also ensure you are provided with an outgoing property condition report. If anything needs to be addressed the cost will be recovered from your share of the bond.

Similarly, if you move into a share house ask for the tenancy agreement to be varied to list you as a co-tenant and add your name to the bond. The landlord/agent should provide an up-to-date property condition report. As the new co-tenant, you cannot be held responsible for the condition of the property before you moved in.

We advise only entering into shared tenancy agreements with people you trust and communicate well with. We know this can be difficult to gauge when replying to an ad looking for a house mate, so we recommend putting everything of importance in writing to protect yourself. This may include agreements about how and when rent and bills are paid, responsibility for everyday cleaning and maintenance of the property, ownership of any shared belongings and use of common areas.

If one tenant has paid another tenant's share of rent or other money owed to the landlord, the tenant can apply to the court for an order they be repaid by the other tenant. If you need assistance with money owed by a co-tenant or other similar dispute, reach out to your local community legal centre for more advice.

When everyone decides to move out of a share house the tenancy ends in the typical way.

#### Don't sweat it! How your fitness journey is protected by WA law

How's that new year fitness resolution going? Maybe the January eagerness to get to the gym has worn off or you're nearing the end of a 12-week fitness challenge and you're feeling the pressure to sign up for another one. The good news is, no matter what you decide to do with your fitness goals, you are protected by Western Australian law when it comes to using fitness service providers.

In July 2021 the rules governing WA's fitness industry changed to provide better protection for consumers. The Fitness Industry Code of Practice applies to providers such as personal trainers, group exercise organisers and yoga classes.

Despite this, we have seen a 33 per cent increase in complaints from 103 in 2022 to 137 in 2023. The vast majority involve disputes over membership cancellations, and payments and refunds.

The Code has been in place for nearly two years. There is no excuse for flouting the rules, so Consumer Protection is putting the fitness industry on notice.

Charging over \$1,000 to cancel membership within the seven-day cooling off period is not what we consider to be reasonably reflective of the administration costs incurred. Using high pressure sales tactics to get people to sign up to expensive "12-week fitness challenges" is breaking the law. Providers cannot make people physically come into the gym to cancel membership contracts. These are just some of the types of complaints Consumer Protection is still seeing.

Consumer Protection has a few training tips for when it comes to engaging a fitness service.

Your membership agreement must include a summary statement to help you understand your responsibilities and it should also state whether it involves an ongoing month-to-month renewal or is a fixed term contract of no longer than 12 months. You must be notified before your membership is automatically renewed.

Should you decide the fitness service is no longer for you, you won't need to arrive in-person to cancel your membership. Cancellations can now be made by email, with direct debits required to stop immediately. High pressure sales tactics and harassment are banned.

After first signing-up, you have up to seven days to cancel your membership and you should only pay for administration costs or services used. If you want to cancel at any point after this seven day period, the most you can be charged on your membership is 30 days after your notice of cancellation.

Take the time to re-assess your new year resolutions and fitness goals. Consumer Protection is your cheer squad.

#### WA Federal MP's & Senators must support introduction of new vaping laws

Cancer Council WA is urging the WA community to contact their Federal MP or Senator asking them to support the introduction of new vaping laws that will assist in putting an end to the current teen vaping epidemic. Ashley Reid, Cancer Council WA's CEO, states that Federal politicians need to hear first-hand the devastating effects that vaping is having on young people.

- The figures for teen vaping are staggering. Between 2019 2023, vaping increased five-fold among teenagers aged 14 to 17 years
- The Federal Government plans to introduce a draft law, which, if passed, will end the domestic manufacture, supply, advertising, and commercial possession of nontherapeutic vapes
- This means people with a medical prescription would still be able to buy vapes from a pharmacy, but they would no longer be in easy reach for kids and teens
- As vaping has become more common, schools are grappling with disruptive behavioural issues and how best to support students who have unwittingly become addicted to nicotine
- We know that vaping poses serious health risks, including nicotine addiction, poisoning, seizures, burns and acute lung injuries from inhaling harmful chemicals.

Whether you are a parent, teacher, health professional or concerned member of the public, we have all witnessed the insidious uptake of vaping by young people in our community. Now is the perfect time to tell decision makers that enough is enough. We urge the WA community to download the <a href="Cancer Council letter template">Cancer Council letter template</a> and email their Federal MP or Senator to let them know why this issue is so important.



# Landcare matters

NRM is the management of natural resources such as land, water, soils, plants and animals. It brings together land use planning, water management, biodiversity conservation and sustainability of industries such as agriculture, mining, tourism, fisheries and forestry.



## Rabbit control - What you can do

European rabbits have a huge impact on the natural environment and agricultural activities. It is estimated that rabbits cost Australian Agriculture \$216 million in production losses each year. Rabbits are one of the most widely distributed and abundant animals in Australia. They have a rapid rate of reproduction with a female rabbit becoming sexually mature at just 4 months of age and they can have 5 or more litters per year with up to 5 young in each litter.

To control rabbits on your property you first need to assess and understand the problem and to plan your control methods. There are a number of control methods to choose from including warren destruction, ground shooting, 1080 baiting, RHDV1-K5 rabbit virus release and trapping. Warren destruction can be quite effective as rabbits depend on warrens to shelter from the heat and to provide protection from predators. There is no silver bullet for rabbit control, control efforts need to be coordinated and ongoing with the greatest success achieved when neighbouring property owners are involved.

The Pestsmart website has some great resources on rabbits and their control including the comprehensive Glovebox Guide which is available on their website or you can pop into PHCC's Boddington Office for your free copy.

#### **COOK LABOR GOVERNMENT DESERTS LIVE SHEEP EXPORT INDUSTRY**

Premier Roger Cook has deserted farmers and shown his true intentions after admitting in Parliament last week to talks with Federal Agriculture Minister Murray Watt to end the live sheep export industry.

Deputy Nationals WA Leader and Member for Roe Peter Rundle MLA asked the Premier in Question Time last week to explain why the Minister for Agriculture had been in secret talks with Canberra around a transition package for farmers.

"Instead of fighting for WA farmers and ensuring our \$132 million live export industry continues, the Premier confirmed the State Government has been meeting with the Federal Government around plans to shut down the industry.

"Members of the Labor Party also denigrated Parliament, making loud animal noises when questioned about their support for live export until they were chastened by the Speaker," Mr Rundle said.

"It was an absolutely disgraceful response from the Premier and further proof that the Cook Labor Government is no friend to our live export sector or our primary producers."

Mr Rundle called on the Premier to sack the Minister for Agriculture for her failure to stand up to Canberra and support live export.

"The Minister refused to stand up and demand the Prime Minister meet with representatives from the live export sector during his recent visit to WA, and the Minister was also silent during the MV Bahijah debacle," Mr Rundle said.

Candidate for Central Wheatbelt Lachlan Hunter said WA farmers deserved better than an arrogant and dismissive Labor Government. "I attended several of the live export forums around regional WA in recent weeks, and farmers are frustrated by the lack of support they have received from the Cook Labor Government," Mr Hunter said.

"The decision to close down the live export trade threatens hundreds of jobs in WA, and will have disastrous flow on effects to our sheep and wool industry, and potentially to our cattle exports as well."

Mr Hunter also called on the Federal Government to release its Independent Panel Report into the phasing out of live sheep, which was completed in 2023.

"It's becoming more and more obvious that Labor doesn't want to release it's so called scientific and economic evidence behind closing the live export trade because it simply doesn't exist.".

#### THE NATIONALS WA SUPPORT LAW-ABIDING FIREARM OWNERS

The Nationals WA have opposed the new Firearms Act 2024 proposed by the Cook Labor Government.

Lachlan Hunter, The Nationals WA candidate for Central Wheatbelt, said The Nationals WA had taken a common sense approach to assessing the legislation and would not support it in the current form. "The changes lack proper justification or evidence, and ignores recommendations made by the Law Reform Commission, which conducted an in-depth review of the existing legislation," said Mr Hunter.

"Despite the assertions made by the Police Minister, these laws will not effectively reduce gun crime. Instead, Labor's persistent attacks and fearmongering have made law-abiding firearm owners feel like criminals."

While The Nationals WA supported certain aspects of the Bill, they have expressed significant concerns about several provisions affecting regional stakeholders, as well as sporting and recreational shooters.

"Arbitrary limits on firearm ownership, minimum standards of trade for dealerships that may impact small businesses, license categories that only permit owners to perform only one activity per firearm and unintended consequences from the introduction of mandatory health checks are issues we are seeking clarification on in the legislation," Mr Hunter said.

Hon Mia Davies, Member for Central Wheatbelt, said the Government was once again taking an arrogant approach to legislation.

"Last week Labor voted against our motion to send the legislation to a committee for review," Ms Davies said.

"This Government believes they've got the Bill perfect, yet over the last four years they've had to patch up 21 pieces of their own legislation after they've introduced them to Parliament.

"The Legislation Committee has looked at just one Bill in the last three years, and on that occasion, they found the Government had introduced the legislation into the wrong House!"

Ms Davies said The Nationals WA would oppose the legislation saying law-abiding firearm owners should not be penalised because the Labor Government has lost control of law and order in the State.

"This is a significant reform for the State and the Government should be using every avenue to get the legislation right," she said.


The maps of the proposed expansion are always a hot topic, but also this week,

### **Stock Crossing**

### Do you Know the Technical Guidelines


#### General

The removal or covering of stock crossing signs when not in use is mandatory. Signs that are displayed while not in use may bring all signing into disrepute and may result in motorists disregarding important warnings. Signs should be covered such that they are not visible in all light conditions.

#### Reasonable Warning

#### Stock Crossings with Sight Distance Greater than 300 Metres.

Where a stock crossing is located such that approaching motorists can see the stock crossing point from more than 300m away, signing should be as per Figure below:



Typical Stock Crossing Site

The crossing should desirably not be used when sun glare will interfere with drivers' view of the traffic signs or stock on the road.

Where stock movements are adjacent to or encompass an intersection, STOCK AHEAD and ON SIDE ROAD signs should be used on the side roads, to alert motorists entering the road that there is stock on the road.

The location of the STOCK AHEAD sign should be based on posted speed limit which determines distance from the stock crossing as shown in Table Below:

Posted Speed Limit km / hr	Minimum Spacing Distance
60	120 m
70	120 m
80	180 m
90	180 m
100	250 m
110 / State Limit	250 m

The signs and any flashing yellow lights should be displayed or installed immediately prior to the stock being driven on to the road reserve and covered or removed as soon as the stock are no longer in the road reserve, as per Section 6.1. of Main Roads Western Australia Road Traffic Code 2000




