### Defibrillator

A note to all residents and interested persons that the defibrillator has been installed outside the Shire Office. The device has been located on the right hand side of the wall outside the main entrance and can be accessed at all times in case of an emergency.

### Bowling Green / Tennis Court Refurbishment
