WHEN CAN I BURN?

1 October 2014 To 31 October 2014	Restricted Burning Period NO BURNING WITHOUT A PERMIT (Contact your local Fire Control Officer) CAMPFIRES AND BONFIRES PROHIBITED
1 November 2014 To 21 February 2015	Prohibited Burning Period NO BURNING AND NO FIRES
22 February 2015 To 19 April 2015	Restricted Burning Period NO BURNING WITHOUT A PERMIT (Contact your local Fire Control Officer) CAMPFIRES AND BONFIRES PROHIBITED
20 April 2015 To 30 September 2015	BURN WITH CARE (No permit required)

Burning permits can be obtained from your local Fire Control Officer. Please remember the Fire Control Officers are volunteers - you may have to leave a message and they will get back to you.

Please plan ahead - do not ring a Fire Control Officer on the day you want to burn and expect a permit, as it may not be granted. You must give notice to your neighbours, Shire and the Fire Control Officers need to be contacted well in advance of that.

HARVEST BANS

You may register your mobile phone number at the Shire Office to receive a text message in the event of a harvest ban or Emergency Broadcast (if you have not already done so).

The harvest ban information line will again be operational. Just dial 9884 1042 to hear the recorded message.

Bush Fire Notice 2014 - 2015 Shire of Wandering

As a land owner or occupier, you have a responsibility under the Bush Fires Act (Section 33) 1954 to manage your property to reduce the risk of fire.

This notice advises what actions you must take by **31 October 2014**, and maintain through the Restricted and Prohibited Burning Periods, to **avoid a fine**. If you do not meet your responsibilities, you may be fined a minimum of **\$250** and be required to meet the cost of Council's efforts to make you comply with this notice.

1. Properties in Blackboy Springs and Wandering Downs Estate:

Clear firebreaks, not less than 2 metres wide, inside and within 20 metres of the road reserve.

2. All other small rural holdings with an area of 80 hectares or less:

Clear firebreaks, not less than 2 metres wide, inside and within 20 metres of the entire boundary.

3. Combined rural holdings in the Shire of Wandering greater than 80 hectares:

Satisfy at least one of the following conditions:

(i) Have on stand-by an operational mobile fire-fighting unit of minimum 450 Litre capacity. If you own more than one land holding in the Shire of Wandering, a minimum of one unit is required for the total land holding

or

(ii) Clear firebreaks of not less than 2 metres wide, inside and within 20 metres of the boundary of all rural land held.

You must also:

(i) Clear firebreaks not less than 2 metres wide, within 20 metres of the perimeter of all buildings on the land. It is recommended that all flammable material be removed for a distance of 2 metres immediately adjacent to all buildings.

and

(ii) Clear firebreaks, not less than 20 metres wide, around the perimeter of any bush exceeding 10 hectares in area prior to carrying out a clearing burn.

4. Town site land:

(i) Clear firebreaks, not less than 2 metres wide, inside all external boundaries of the land

and/or

(ii) Clear, by burning, all flammable material likely to be conducive to the outbreak, spread or extension of a fire from the whole of the land

and/or

(iii) Maintain grass to a height not greater than 10cms.

5. Plantations (a clump of planted trees greater than 10 hectares in area):

- (i) Clear firebreaks, not less than 10 metres wide, immediately inside all external boundaries of land.
- (ii) Clear internal firebreaks, not less than 10 metres wide, surrounding compartments of maximum area of 100 hectares.

A Firebreak is a strip of land that has been cleared of all trees, bushes and grasses (e.g. Sprayed, ploughed, cultivated, scarified) and any other flammable material, leaving clear earth. This includes the trimming back of all overhanging trees, bushes, shrubs and other objects over the fire break area. Firebreaks must be maintained clear of all inflammable materials during the Restricted and Prohibited Burning Periods.

All properties will be inspected from 31 October 2014 to ensure they comply with these requirements. Failure to comply will result in an infringement being issued.

If for any reason it is impracticable to construct firebreaks by 31 October 2014, please notify the District Chief Fire Control Officer or the Shire Chief Executive Officer to seek Council approval to provide them in an alternative place. If permission is not granted, the requirements of this Notice shall be complied with.

If you are unable to install a firebreak yourself on your property, there are local contractors who may provide this service. Contact the Shire for more information.

Harvest, Baling and Chaffing Cutting During Restricted and Prohibited Burning Periods

During harvest, an operational mobile fire fighting unit of minimum 450 Litre capacity must be in close proximity to the harvest activities at all times.

During Harvest and Baling an operational fire extinguisher must be provided. During chaff cutting, a fire extinguisher, together with a container of at least 450 Litres of water, is to be provided at the site of chaff cutting operations.

Please Note:

- Ploughing of roadsides in the Shire of Wandering is prohibited. Burning on roadsides is only permitted outside the Restricted and Prohibited Burning Periods and only in **HEAPED PILES** (ie. no strip burning).
- Camp fires within the Shire of Wandering during the restricted and prohibited burning period are prohibited.
- Rural property owners are urged to fit a 38mm male camlock coupling and check valve to their water storage tanks to allow easy access to water by fire fighters.
